**INDEPENDENT INTERNAL AUDITOR'S REPORT
ON APPLYING AGREED-UPON PROCEDURES**

Members of the Northampton County Council

County of Northampton, Pennsylvania

We have performed the procedures enumerated below, which were agreed to by the County of Northampton's Administration solely to assist you with evaluating the Hotel Room Rental Tax Remittances from License #152 View Inn Suites LLC for the period January 1, 2016 to December 31, 2017. County management is responsible for ensuring that Operators within Northampton County are collecting this tax from their guests and that Operators remit the tax they collect to the County. The sufficiency of these procedures is solely the responsibility of those parties specified in this report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

Procedures and Findings

- 1. Procedure:** Determine if taxable revenues, exempt revenues and taxes due as reported are accurate.

Findings:

- In November and December of 2017, the hotel claimed exemptions but did not supply supporting documentation with their remittance forms.
- The hotel's exemptions for November 2017 were overstated by \$148.00 due to duplicate exemptions for the same day/same room and not being able to provide an exemption certificate for one guest.
- The hotel's exemptions for December 2017 were overstated by \$9,472.00 and one exemption was invalid. However, this was offset by hotel tax revenue reported to the County that was overstated by \$9,687.29.

- 2. Procedure:** Determine if the Operator is using the latest version of the remittance form and that the form was fully completed in a proper and accurate manner.

Findings:

- In 2016, five of the 11 remittances were postmarked or received after the 20th of the month resulting in tax and interest due to the County in the amount of \$6,848.83.
- In April 2016, no remittance was submitted.
- In 2017, seven of the 12 remittances were postmarked or received after the 20th of the month.


Based on the findings above, we determined that the View Inn Suites LLC owes Northampton County \$8,729.43 in hotel room taxes. See Exhibit 1 for additional tax due from the hotel.

We conducted this agreed-upon procedures engagement in accordance with generally accepted government auditing standards. We were not engaged to and did not conduct an examination or review, the objective of which would be the expression of an opinion or conclusion, respectively, on Hotel Room Rental Tax Remittances from License #152 View Inn Suites LLC. Accordingly, we do not express such an opinion or conclusion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

This report is intended solely for the information and use of the management of the County of Northampton, Pennsylvania and is not intended to be and should not be used by anyone other than these specified parties.
