This ordinance was advertised on the 9th day of November, 2022, and was adopted by the Northampton County Council on the 18th day of November, 2022.

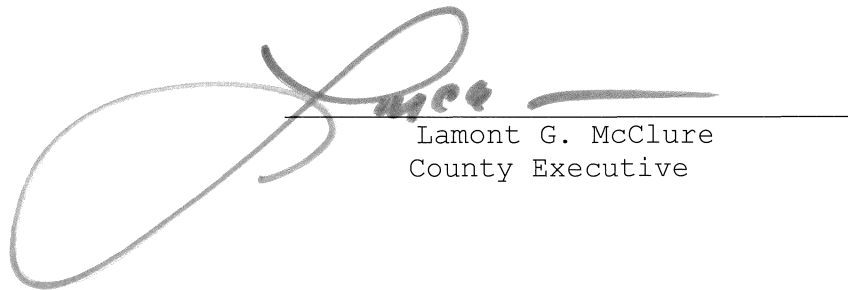
