

November 3, 2020 General Election
Uniformed Military and Overseas Voter Act (UMOVA)
and Federal Write-in Absentee Ballot (FWAB)
Northampton County, Pennsylvania Board of Elections

The Northampton County Board of Elections, pursuant to the provisions of P.L. 1333, known as “The Pennsylvania Election Code”, hereby gives NOTICE that elections are to be made for the following public offices in Northampton County at the November 3, 2020 General Election:

Public Office

President of the United States and Vice President - Vote for One, All Precincts within Northampton County
Attorney General - Vote for One, All Precincts within Northampton County
Auditor General - Vote for One, All Precincts within Northampton County
State Treasurer - Vote for One, All Precincts within Northampton County
Representative in Congress (7th District) - Vote for One, All Precincts within Northampton County
Representative in the General Assembly 131st District (One)
135th District (One)
136th District (One)
137th District (One)
138th District (One)
183th District (One)

Who is covered under UMOVA?

Covered voters include all of the following;

1. A uniformed-service voter who is registered to vote in the Commonwealth, which includes a veteran who is bedridden or hospitalized due to illness or physical disability.
2. An overseas voter who is registered to vote in the Commonwealth.
3. A uniformed-service voter who is not registered to vote in the Commonwealth but who otherwise satisfies the voter eligibility requirement of this Commonwealth: and
4. An overseas voter who is not registered to vote in the Commonwealth but who otherwise satisfies the voter eligibility requirements of this Commonwealth.

How do you apply for a military-overseas ballot?

1. Covered voters who are registered to vote in the Commonwealth may apply for a military-overseas ballot using either an absentee ballot application or the Federal Post Card Application (FPCA).
2. Covered voters who are not registered to vote in the Commonwealth may use a FPCA to both register to vote and apply for a military-overseas ballot simultaneously.
3. A uniformed-service voter may use the FWAB to apply for a military-overseas ballot and vote at the same time.

Instructions

- You may request an absentee ballot from this office at any time prior to a primary or election. However, if time does not permit you to receive and return an official absentee ballot, you are also entitled to vote using the FWAB.
- You may use FWAB to vote for a candidate for U.S. Representative in Congress, as well as candidates for all state and local offices, and ballot initiatives.
- To receive an FWAB, visit www.fvap.gov or www.votespa.com
- To vote, refer to page 3 of the FWAB.
 1. To vote for U.S. Representative in Congress-write in the name of the candidate in the space provided on the FWAB.
 2. To vote for state and local offices or for ballot initiatives-write the names of candidates or the ballot initiative in the Addendum Section of the FWAB.
 3. Under the **Office/Ballot Initiative** heading, enter the office the candidate is running for or the title of the Ballot Initiative (referendum).
 4. Under the **Candidate Name, Party Affiliation or Initiative Vote** heading, list the name of the candidate you wish to vote for, or if you are voting on a referendum questions write "yes" or "no".

REPRESENTATIVE IN THE GENERAL ASSEMBLY – 137th Representative District – Vote for One – Boroughs of Bangor, East Bangor, Nazareth, Portland, Roseto, Stockertown, Tatamy- Townships of Forks, Lower Mt. Bethel, Palmer (Middle 1, Up Eastern,Up Western), Upper Mt. Bethel, Upper Nazareth, Washington

REPRESENTATIVE IN THE GENERAL ASSEMBLY – 138th Representative District – Vote for One – Boroughs of Bath, Chapman, Pen Argyl, Wind Gap - Townships of Bethlehem (Wards 01, 3-4, 3-5, 04) Bushkill, East Allen, Hanover, Lower Nazareth, Moore (Eastern, Pt. Phillips) Plainfield

REPRESENTATIVE IN THE GENERAL ASSEMBLY – 183rd Representative District – Vote for One – Boroughs of North Catasauqua, Northampton, Walnutport - Townships of Allen, Lehigh, Moore (Beersville, Klecknersville)

Instructions

- This ballot can be used to vote for federal offices.
- DO NOT write your name or any identifying number (SSN, driver's license) on this ballot.
- Photocopy this page if you require additional room for candidates or ballot initiatives.
- If you are voting in American Samoa, Guam, Puerto Rico, or the U.S. Virgin Islands, you may vote for Delegate or Resident Commissioner, and in presidential primaries. State laws vary about using the FWAB for other offices like Governor or Mayor. Learn more online at [FVAP.gov](https://fvap.gov).
